All class sessions are supervised by qualified personnel trained in the procedures and traditions of dance instruction.

_____ Student(s) hereby represent that he/she is physically able to take the prescribed course of instruction.

_____ I understand that tuition fees are to be paid in the specific installments based on the dancer's registration of total class hours and is not affected by lesson schedule and/or attendance. Homeschool program hours and evening hours are not able to be combined.

_____ I understand that I am to keep a valid credit card on file in my account at all times, available for automated fees.

_____ I understand that I must pay all fees on a regular basis by the due dates, any unpaid amounts are at risk of being sent to a collection agency. All Unpaid amounts as of June will be sent to collections.

_____ I will faithfully comply with all rules and regulations of South Florida Dance Company facility. I further understand that failure to complete the lessons does not relieve me of my obligation to pay the tuition in full. I also agree that no tuition will be returned to a student for any reason.

_____ I understand it is my responsibility to stay up to date on parent information, through BAND, email, Facebook etc. Throughout the year SFDC will send important information regarding performances, events, parent updates etc...

_____ If your dancer has an injury, please notify us right away. If they need to sit out, please get a doctor's note describing the injury and any limitations as well as an expected time frame.

_____ I authorize South Florida Dance Co. to debit my account/credit card automatically on behalf of South Florida Dance Company operated by South Florida Dance Company Inc. for purposes of collection and distribution in accordance with my agreement with South Florida Dance Company. The information I have provided to the school and South Florida Dance Co. is true and correct to the best of my knowledge.

_____ I agree to pay the facility for instructional services rendered and fees associated, payable in installments as agreed. I understand that my account will be debited on the day and in the amount agreed to with the school. Note: a \$15.00 late charge will be assessed for any accounts that are 10 days past due.

_____ Dancers will not be permitted to dance with an outstanding balance, past 10 days.

_____ All parents and students will always conduct themselves in the utmost appropriate manner, including performances and events outside of the Facility, representing South Florida Dance Company. This includes but not limited to inappropriate behavior or conversations. Negative comments, slander, or defamation of SFDC, staff, families, students, or owners, in any public forum, social media, digital environment. We reserve the right to forfeit this agreement and to remove a student from our studio for any actions we deem as misconduct and/or inappropriate by the student, family member, or friend of the student.

_____ I understand that the tuition in this agreement is monthly tuition. Recital fees, costumes, tickets, photography packages, videos, performance fees, competition fees etc.... are NOT included in the tuition.

_____ There are No refunds at any time, including missed classes for personal reasons, inclement weather or acts of God. I understand that if St. Lucie County Schools are closed due to inclement weather all classes will be canceled for that day as well. However, your account may be frozen due to a doctor documented medical excuse. These will be dealt with on an individual basis and are at the discretion of the executive Director.

_____ SFDC will be videotaping and/or taking photographs of our students in class, special events and performances. We would like your permission to use these photographs for publicity purposes, and to show you and the community organizations some of the programs at SFDC. If I withdraw my child from SFDC and my account is in good standing, all future regular tuition, fees, and payments will be terminated. There is NO cancellation fee.

_____ Dance shoes: **Dance shoes should NEVER be worn outside of the dance rooms.** Dancers should not wear their shoes to walk to/from the car. Hip Hop sneakers are not regular shoes, they are dance sneakers that are only worn in the dance room.

Release and Waiver of Liability, Indemnity Agreement, Policies and Guidelines

I understand and agree that, if at any time, I feel anything to be UNSAFE, I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.

_____ I/WE fully understand and acknowledge that: (a) There are risks and dangers associated with participation in dance classes, events and activities which could result in bodily injury, partial and/or total disability, paralysis and death. (b) The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe. Policies and Guidelines

- Students are to be in proper dress code during all classes and rehearsals. Students who are not in proper dress and hair will NOT be permitted to take class/rehearse.
- Cellphones are to be silenced and put away in the dancer's bag or locker in the dressing room. No phone calls, recording videos, picture taking, or social media during class time or in the dressing room.
- Food and drink are prohibited in the studio rooms. Students may eat in the lobby in assigned areas and must clean up after themselves. **Clear bottles water only at the studio, NO Stanleys, NO Starbucks/Dunkin, NO Gatorade or any color drinks, NO Exceptions.**
- Students must clean up after themselves after class; this includes all personal belongings and trash (ie. toe pads, bandages and wrappers, water bottles, paper trash, napkins etc.) Respect the space and all who use it.
- Parents are not permitted to enter the studio rooms during class time. If you need to speak with a teacher, please privately BAND message, or leave a note at the desk for the teacher to call or set an appointment to meet.
- Students missing 2 or more excused/unexcused classes are at risk of losing their part or placement in a dance piece, performance, or special activity, and may be removed all together. Students are responsible for learning the missed choreography before returning to class.
- Parents/Students are responsible for communicating absences and tardiness to the front desk by calling/texting/emailing/BAND messaging the office.
- Parents/students should not contact instructors/directors through their personal phone/email/social media, please use the studio phone/email/BAND to contact for any studio needs. (Thank you for your cooperation and understanding on this)
- Parents and students are expected to behave in an acceptable, friendly, and professional manner. This is a place for children to learn the art of dance in a warm and positive atmosphere. All parents and students will always conduct themselves in the utmost appropriate manner, including performances and events outside of the Facility, representing South Florida Dance Company. This includes but not limited to inappropriate behavior or conversations. Negative comments, slander, or defamation of SFDC, staff, families, students, or owners, in any public forum, social media, digital environment. We reserve the right to forfeit this agreement and to remove a student from our studio for any actions we deem as misconduct and/or inappropriate by the student, family member, or friend of the student. Again, if you have a concern, please see an instructor or the office manager to discuss.
- Parents should drop off/pick up students at class time. Please make sure that the student is dropped off no more than 10 mins before class and picked up immediately after class.
- Parents and students are responsible for staying up to date and current on all studio correspondence, and includes emails, social media, BAND and paperwork announcements. BAND is our primary communication for important updates and information.
- Complaining about casting is not tolerated and is completely unacceptable. Students are at risk of being removed from their casting or performance.
- Class/Level placements are at the discretion of the Instructors and Directors. Student grade/age, ability, Skill level, technique and maturity are all factors involved when deciding class/level placement. Any concerns must be brought to the director's attention.
- If there are social conflicts or disturbances amongst students within a class, parents/students should resolve these first. If the issue cannot be resolved an appointment can be made with the directors/instructors to discuss.

****Please read, initial, and sign:**

Holiday Production:

____ The Christmas Spectacular fee of \$250 will be charged for all students that audition to participate on the day of Audition 9/12/26. This includes Saturday rehearsals, performance fee, costume rental, T-shirt & video of the show. Any fee accepted after the audition date will have a \$15 late fee.

Recital Uniform Package:

____ Uniform Package \$230: 1 dance uniform, 1 pair of tights (if needed), any accessories. Alterations sewn by our professional seamstress. Video of the recital performance, Recital T-shirt, Class pictures in program, 1 copy of Full-size Souvenir Recital Program, participation in all rehearsals and recital in a professional theater.

____ Additional class recital fee \$135 per add'l class after initial package above

____ Year-End Recital deposits will be automatically charged to the card on file for your child as of 10/25/26. Your Recital deposit is 50% of the *total of all your Recital Fees. Payments towards Recital Fees can be made any time once the season starts. Any deposit accepted after 11/15/26 will have a \$15 late fee.

____ If your student will not be participating in the year end recital, please see the desk before 10/15/26 to ensure you are not charged.

____ All remaining Recital Fee Balances will be automatically charged on 12/17/26.

____ There will be NO refunds at any time on money paid for show fees.

____ Photo packages, additional T-shirts etc will be available to purchase.

____ Additional programs, t-shirts, and photo packages will be available to add to your year-end recital package. *Year-end Recital

South Florida Dance Company Dress Code 2026-2027

(Initial and sign)

ALL uniform items must be purchased through South Florida Dance Company, except for some dance shoes.

Ballet: SFDC Logo leotard, convertible ballet pink tights.

Hip Hop: SFDC branded pants or shorts, any SFDC branded t-shirt, hair up in pony and off face.

All other styles: choice of SFDC branded leotard or athletic top, with SFDC branded leggings or shorts.



NO Bras showing. Leotard should be fitted properly, if dancer needs coverage/support, they can wear a nude camisole leotard under, proper nude dance bra with all clear straps or nipple covers. NO regular bras.

*Hair **MUST** be in a proper bun for ballet. NO Bows, head bands, scrunchies or any other oversized hairpieces. ALL other classes hair should be up and back off face (ponytail, braids, bun)

Dance Shoes:

Tap: Black leather tap shoes (not shiny, available to order)

Jazz, Leaps & Turns, Musical Theater: Skin tone leather jazz shoes (available to order)

Contemporary: Skin tone half soles (turners, pirouettes)

Ballet: Preschool- Ballet leather ballet flats, Ballet 2-5 stretch canvas ballet flats. (available to order)

Modern, Acro: Bare foot

Hip Hop: Black, white or black/white sneaker

****Your dance shoes are NOT to be worn outside of the studio at any time**** (if shoes are worn from home or to walk through the parking lot etc, they collect dirt/debris that damages the flooring as well as the kid's dancewear)

*****Students not in proper hair/dress will not be permitted to dance*****

NO JEWELRY, dancers are not to wear jewelry to the studio. SFDC is not responsible for lost jewelry when dancers are asked to remove it.

****** Please do not wear any perfumes, scented lotions, oils, or spritz and do not apply these here at SFDC. This includes scented hand sanitizer. We have many students and staff with asthma, scent allergies etc******

Students must have a dance bag or rent locker for shoes, dance notebook/journal, extra hair ties/pins, all accessories and anything else required by the student's level of dance. They are not to have loose items, this include their street shoes, that should be stored in a bag/locker during class.
